Our Projects

Ason Group has worked on numerous projects across a number of fields. Some of our recent projects include:

South Village, Kirrawee Brick Pit:

A mixed-use development comprising a 15,500m² local shopping centre (with community facilities) and 750 residential units. Ason Group staff have worked on this project since the Part 3A Application works commenced in 2010 and were retained as the lead traffic consultant for the 2014/15 Section 75W (MOD 3) application and the current Development Application (DA) with Council.

Edmondson Park Town Centre:

A mixed-use development incorporating some 35,000m² of retail floor space and 1,600 residential

dwellings. We were engaged by Australand / Frasers at the bid stage and are responsible for the

delivery of all traffic and transport related aspects of the project.

Oakdale South Industrial Estate:

A State Significant DA (SSDA) to the Department of Planning for the development of a 117 hectare

industrial precinct incorporating some 380,000m² of industrial floor space. The SSDA also includes

the development of roads and internal infrastructure to accommodate the future development.

North Ryde UAP:

Two major mixed-use developments forming a significant potion of the North Ryde Urban Activation

Precinct. Ason Group has been engaged by both Australand / Frasers and Country Garden to deliver

a total of 1,250 residential dwellings and ancillary retail GFA. The project has required significant

consultation with RMS, Council and Transport for NSW as a consequence of the location of the site. We have been involved in all aspects of the development approval and construction/delivery process.

Orchard Hills Industrial Estate:

A proposed new industrial estate located within the broader WSEA, Ason Group is currently the lead

traffic consultants working on the Planning Proposal application to NSW DPE. The main focus of the

project has involved developing an access solution that satisfies the objectives of the client whilst

aligning with the future plans of RMS to upgrade the Mamre Road corridor.

Bungarribee Business Hub:

A major new business hub being developed by the Western Sydney Parklands Trust incorporating

retail, commercial, industrial and recreational land uses. Ason Group has assisted in the preparation

of traffic studies to assist in the design of the facility including internal infrastructure and new road

connections with the Great Western Highway.
